

HSBC HK App "Laisee 2023 Lucky draw" Promotional Terms and Conditions:

When can you enjoy the offer

 The promotional period of HSBC HK App "Laisee 2023 Lucky draw" (the "Programme") is from 16 January 2023 to 16 February 2023 (both dates inclusive) (the "Promotional Period"). The Hongkong and Shanghai Banking Corporation Limited in the Hong Kong Special Administrative Region ("Hong Kong") (and its successors and assigns) ("HSBC" or the "Bank") reserves the right to change the Promotional Period at its discretion without prior notice.

Who can enjoy the offer

- 2. The Offer is exclusive to existing customers of the Bank who fulfil all the following requirements ("Eligible Customer"):
 - (a) being aged 18 or above on 15 January 2023; and
 - (b) have a valid Hong Kong correspondence address and email address under the Bank's record; and
 - (c) being the sole or (if a joint account) principal account holders of any HSBC personal bank accounts (the "Applicable Account"); and
 - (d) hold Applicable Account and it is valid during the Promotional Period.

Offer details:

3. During the Promotional Period, Eligible Customer can get one (1) lucky draw chance automatically upon fulfilling the Criteria and the below conditions (Category B and C are limited to one chance each), up to a maximum of thirty-four (34) lucky draw chances:

- (a) Any transactions which are not performed on the HSBC HK App will not be regarded as eligible transactions; and
- (b) The total Laisee transaction is reset to zero (0) on daily basis during the Promotional Period; and
- (c) A day will be defined as the local time of Hong Kong (GMT +8) from 00:00 to 23:59; and
- (d) The transaction time is based on the time of receipt by systems of the Bank; and
- (e) Multiple transactions sending to a single proxy ID (mobile or email) shall be counted once only.
- 4. Eligible Customer can participate in the lucky draw more than one (1) chance in Category A during the Promotional Period. For example, Eligible Customer sends Laisee on the first and second day of the Promotional Period, he/she will be entitled two (2) lucky draw chances and so on; while Category B and C are limited to one (1) chance each.
- 5. Category A, B and C will be selected by luck draw after the Promotional Period, while each eligible winner is entitled to be awarded all cash rebate amount (the "Prize") under each Category with a maximum of HKD 308.
- 6. Eligible winner shall maintain the Applicable Account and be a valid Personal Internet Banking user at the time of the fulfillment.
- 7. The Prize will be credited to the Eligible Customer's Applicable Account on or before 30 June 2023 according to the Bank's record at the time of the fulfillment.

- 8. An Eligible Customer's personal information in the Bank's record must be valid and up to date during the Promotional Period and at the time of offer fulfilment in order to be entitled for the Prize.
- 9. The Bank has the sole and absolute discretion in determining a person's eligibility to receive the Prize. If the Bank discovers at any time, whether after or during the Promotional Period, that any person has failed to comply with these terms and conditions, the Bank is entitled to disqualify the person from participating in the Programme and receiving the Prize.
- 10. The Bank further reserves the right to exclude an Eligible Customer who violates these terms and conditions, tampers with the Programme, engages in abusive, deceit or

fraudulent behavior in relation to the Programme or makes false representations or statements or violates applicable law or regulations. If an Eligible Customer is excluded, the Prize may be subsequently revoked and reclaimed.

- 11. It is the Eligible Customers' responsibility to comply (at their own expense) with any laws requiring payment of any tax, duty, levy or similar impost relating to the award of the Prize, and the Bank shall have no responsibility in respect thereof.
- 12. No person other than the Eligible Customers and the Bank will have any right under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefit of any of the provisions of these terms and conditions.
- 13. In the event of any dispute arising from the Offer, the decision of the Bank shall be final and conclusive.
- 14. The Bank reserves the right to change these terms and conditions (including the dates of the Promotional Period) and terminate the Programme at any time.
- 15. If there is any conflict between the information contained in the promotional materials and these terms and conditions, these terms and conditions shall apply and prevail.
- 16. The Programme and the Prize are provided subject to the prevailing regulatory requirements.
- 17. The Programme is held within Hong Kong. These terms and conditions shall be governed by and construed in accordance with the laws of Hong Kong and each Eligible Customer submits to the exclusive jurisdiction of the courts of Hong Kong.
- 18. In the event of any discrepancy or inconsistency between the Chinese and English versions of these terms and conditions, the English version shall apply and prevail.
