Specific Terms and Conditions

- 16. The 8% First-year Premium Discount is only applicable to successful applications in respect of a new purchase of WGIP2/HGIP/FGIP from the "Eligible HSBC Customers" mentioned in Clause 1 (for WGIP2/HGIP/FGIP policy).

 - single premium X 0.02 (as the case may be) (for ANNB2policy) OR
 - single premium X 0.0267 (as the case may be) (for WGIP2/HGIP policy) OR
 - single premium X 0.014 (for ULEP/ULPP policy)
- 22. For aggregate premium, the premium discount provided will be calculated as follows:
 - full annual premium X 0.06 (as the case may be) (for FIAP policy)
