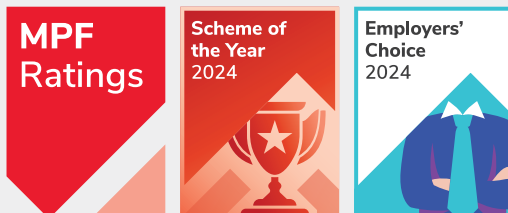

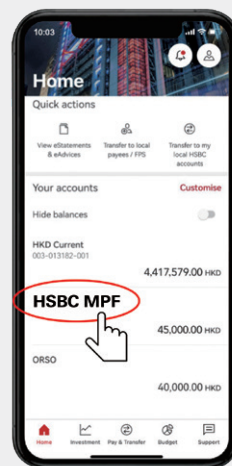
The average fund expense ratio for HSBC MPF Constituent Funds is 1.19%³, which is more than 15% lower than the market average of 1.41%³
